Authorization To Enter Into An Agreement For Pictometry Services

WHEREAS, the Town Assessor is charged with maintaining the Assessment Rolls at a level of assessment of 100% equalized and complete an on-site inspection of the Town's inventory; and

WHEREAS, the Town has more than 5,575 parcels and the number needing to be physically seen can be reduced by the use of aerial imagery in accordance to NYS Office of Real Property Tax Services guidelines enabling the Assessor to review certain parcels using the technology and thereby accelerating the number of total parcels that may be updated each year; and

WHEREAS, in 2008/2009 Clinton County secured a grant that enabled the County to procure aerial imagery from a company called Pictometry International Group that made it possible for all municipality's Assessors, and other Departments within the Towns, to experience the use of Pictometry and evaluate its effectiveness; and

WHEREAS, Clinton County will no longer make this service available to municipalities in the County; and

WHEREAS, the City of Plattsburgh has also recognized a need for this service and has expressed an interest in investing in said service with the Town of Plattsburgh to minimize the costs for each municipality; therefore, be it
