Transition of Assessing Services to Clinton County

WHEREAS, the Town Board of the Town of Plattsburgh has carefully examined the needs of the township and has reviewed various service options and alternatives, including budgetary considerations at both the Town and County levels; and

WHEREAS, the Town Board has determined that the recalibration of future assessing services will provide efficiency, customer services and fiscal responsibility; and

WHEREAS, the Town Board, subject to permissive referendum, wishes to transition the Town of Plattsburgh's assessing services to Clinton county Government on contractual basis and notices the transition to become effective October 1, 2025; and

WHEREAS, RPTL 1537 of the Real Property Tax Law ("RPTL") authorizes municipalities with the power to assess real property ("Assessing Unit") to enter into an agreement with a county for appraisal services, assessment services and exemption services, provided that the Assessing United has adopted a resolution subject to permissive referendum to

enter such agreement; and

WHEREAS, the town is an Assessing Unit as defined the RPTL, and a municipal corporation defined in Article 5G of the General Municipal Law; and

WHEREAS, the Clinton County Real Property Tax Service Office has the ability to perform assessment service to the Town; now, therefore

BE IT RESOLVED, by the Town Board that providing the forty-five (45) day permissive period following the adoption of the resolution has expired without the submission of a petition for referendum that the Supervisor is authorized to negotiate and sign an agreement with Clinton County and any related documents necessary to carry out the terms and conditions of the agreement; and

BE IT FURTHER RESOLVED, that the town Clerk is hereby authorized to place a notice in the Press-Republican regarding this resolution and that is subject to permissive referendum; and

BE IT FURTHER RESOLVED, that as a result of this transition, the Town Assessor position will be vacated on October 1, 2025, and no reappointment will be made; and

BE IT FURTHER RESOLVED, that the Assessment Control Examiner position will be eliminated, with the last day of employment being September 30, 2025, coinciding with the transition to contractual services with Clinton County; and

BE IT FURTHER RESOLVED, that a copy of the resolution be provided to the County Administrator and Town of Plattsburgh Business Office, and a copy placed files of respective personnel.

WHEREAS, the Town of Plattsburgh Planning Board has reviewed and approved the Former Clinton County Airport Subdivision 2021; and

WHEREAS, the Former Clinton County Airport Subdivision 2021 has submitted a deed for conveyance of improvements to the Town representing approximately 2500 feet of new public road right-of-way, +road improvements and related water, sanitary sewer, street lighting, and storm drainage; and

WHEREAS, the Town Superintendent of Highways and Building and Grounds Director and have conducted and/or supervised on-site inspection of the constructed improvements and submitted letters recommending the acceptance and dedication of said improvements and new road extension; and

WHEREAS, the Applicant is required to prepare a final warranty deed to the Town of Plattsburgh for the new road and other improvements constructed in the subdivision conveying approximately 2500 feet of new road and associated utilities as identified on the map titled Former Clinton County Airport Subdivision 2021 and identified as Douglas Boulevard; and

WHEREAS, the subdivider shall be required to place with the Town a One-year Warranty Deposit for the road and sewer utilities dedication in the amount of \$25,000.00 (2500 ft @ \$10.00 per ft. = \$25,000.00); and

WHEREAS, the Applicant is required to provide a check to the Town of Plattsburgh in the amount of \$70,000.00 for the cost of Type 6 topcoat asphalt to be installed by the Town Highway Department within one year following acceptance of said road or by a date mutually agreed upon by the developer and the Town Highway Superintendent; and

WHEREAS, there is construction "punch-list" of certain water and wastewater infrastructure improvements that remain to be finalized by the subdivider (Clinton County) and their contractors; and

WHEREAS, the Town of Plattsburgh has agreed to dedicate Douglas Boulevard as a public highway, and to provide additional time for Clinton County to complete said punch-list of improvements pursuant to the Agreement To Complete Post-Road Dedication Conditions Between The County Of Clinton and Town of Plattsburgh; now therefore be it

RESOLVED, that the Town Board hereby receives and places on file the Town Superintendent of Highways, Water and Wastewater Director, Building and Grounds Director letters recommending the acceptance and dedication of said improvements and new road extension; and it is further

RESOLVED, that the Town Board of the Town of Plattsburgh does hereby, upon the final warranty deed being found acceptable to the Town Planning Attorney, accept and dedicate 2500
